The above mentioned parties agree as follows:

1. Doonan Gulch Outfitters agree to provide:
 - a. Camp facilities, consisting of lodge, bunkrooms and/or cabin and adequate food;
 - b. Adequate transportation when necessary for hunting, from established camps for use by hunter and guide;
 - c. A licensed Outfitter or guide who shall work with the hunters (one on one hunts are at additional costs);
 - d. Field care of the animals (field dressing). Caping, skinning, salting, and processing are additional costs.
2. Hunter/client agrees to pay the outfitter for the services mentioned above, the total sum of (U.S. dollars) _____ for the cost of the hunt; with a _____ deposit paid upon booking the hunt, _____ paid upon receipt of a MT hunting license; and balance of _____ due upon arrival at the lodge.

Terms and Refund Policy: (please read carefully)

1. All payments to Outfitter should be either cash, bankdraft, or travelers checks. Initial deposit is non-refundable, with the only exception being cancellation due to death of client, and may be applied to the next hunting year if client is not successful in the draw of Montana hunting license or permit.
2. Outfitter(s) will concentrate on hunter's primary animal listed above. Once that animal is taken, then additional hunting opportunities for varmint and birds may be offered.
3. Outfitter fees DO NOT INCLUDE:
 - a. Cost of transportation to or from hunter's residence to 2 Doonan Gulch Rd;
 - b. Shipping of animal to hunter's residence or taxidermist;
 - c. Shipping of hunter's meat; or
 - d. Processing of game animals or caping.
4. Client is responsible for all of his or her own clothing, firearms, and personal belongings. Outfitter is not responsible for damages or loss to Client's property.
5. Client shall obtain a valid Montana permit or license for the game desired and obey all Montana and Federal hunting and fishing laws and regulations and all instructions of Outfitter, guides and employees. Client will reimburse Outfitter for all costs or fines resulting from Client's violation of any Montana or Federal law or regulation.
6. Outfitter may terminate this agreement for any violation(s) without refund.
7. This agreement incorporates the waiver listed below.

Release and Waiver of Liability:

The undersigned recognizes that there is a significant element of risk in any hunting activity associated with the outdoors. Risks include, **but not limited to**, the following: injuries arising from horseback riding, snake bites, uneven terrain, accidental firearm discharge, vehicle accidents and rollovers; etc. Knowing the inherent risks, dangers and rigors involved in the activities, I certify that my family and I, including any minor children, are fully capable of participating in the activities and accept the risk involved.

I assume full responsibility for my family and myself, including any minor children, for both bodily injury, death, loss of personal property and expenses thereof, as a result of my negligence or the negligence of my family. The undersigned does further release and forever discharge and agree to hold harmless, Doonan Gulch Outfitters, its officers and employees and agents and its heirs, successors and assigns, for and from all manner of actions, causes of action, suits which must be brought to local court in Montana, losses and claims and demands of any natures arising out of or connected with this agreement resulting or to result from any accident which may occur as a result of my participation and recreational activities hereunder.

I further understand the Outfitter reserves the right to refuse any person judged to be incapable of meeting the rigors and requirements of participating in the activities.

I have read, understand and accept the terms and conditions stated herein and acknowledge this Agreement shall be effective and binding upon us during the entire period of participation in activities.
